Summary Of Recall:

Menu Foods Income Fund (MEW.UN.T) is undertaking a precautionary recall of a portion of the dog and cat food it made between Dec. 3, 2006 and March 6, 2007 at two of its U.S. facilities.

The recall is limited to "cuts and gravy" style pet food in cans and pouches. The products are both made and sold under private-label and are contract-manufactured for some national brands.

The fund said it has received feedback in the U.S. about the affects on the renal health of pets consuming the products. It said it discovered that the timing of the complaints coincided with the introduction of an ingredient from a new supplier. The fund stopped using the ingredient shortly after this discovery.

Menu Foods makes wet pet food products sold by supermarket retailers, mass merchandisers, pet specialty retailers and other retail and wholesale outlets.
